This is a Juried art show with no awards or prizes. Only 100 fine artists and artisans will be accepted. \$25 Jury fee applies to all new applicants and previously accepted participants applying after January 31, 2019.

Booth spaces will be strategically assigned to avoid placing artists with similar works in close proximity to one another. Once a space number is assigned, an artist cannot move to another location without permission from show director.

Set-up will begin at 6:00 a.m. Saturday, January 11, 2020. You will forfeit all fees if you do not show for the event and have not contacted Chamber staff at (772) 334-3444 with an explanation for your absence.

Any artist and their work previously accepted through the Jury committee process will have first-priority on keeping their 2019 exhibit space and will have the Jury Fee waived for the 2020 show. Advance payment must be paid by January 31, 2019.

Exhibitors bear the responsibility for all setup and security need for their exhibits. It is our assumption that exhibitors in the show are covered under their own liability insurance policy. All fire department safety lanes and rules will be strictly enforced. Overnight security will be onsite from Saturday 6:00 p.m. until Sunday 9:00 a.m.







The History Jensen Beach Fine Art & Craft Show

In 1966, local art patron and Chamber of Commerce board member. Dr. Richard Pennick, wanted to showcase local artists by featuring them in a local art show. With the help of the Chamber and local art advocates, they joined together to make it happen. The first Festival of the Arts was held on the Jensen Beach Causeway in March during the height of the tourist season. The festival was a juried show and awarded cash prizes. The event successfully continued until 1988.

The Festival of the Arts name was changed to the Sunshine State Art & Craft Show in March 1989. The show continued to be held in March. For the first time, the show invited fine crafters to participate and display their hand-crafted artwork including glass, photography, mixed media, textiles, jewelry and much more. The show was also held on the Jensen Beach Causeway. A highlight of the Sunshine State Art & Craft Show was the flying of the Mount Rushmore American Flag over the event in 1991.

The Sunshine State Art & Craft Show ended in 1994. For the remainder of that decade, and until the Frank A. Wacha, Sr. Bridge construction on the Jensen Beach Causeway was completed in 2006, the Jensen Beach Art League organized several local art shows. In the early 2000's, a South Florida promotion company held an art show on Ricou Terrace in downtown Jensen Beach.

Jensen Beach Chamber of Commerce. President CEO. Ronald Rose felt there was a need for the return of an authentic art show to downtown Jensen Beach. The Jensen Beach Fine Art & Craft Show first began in January 2007, officially kicking off the local art show season.

Rose credits several artists from the Sebastian Riverfront Fine Art & Music Festival in helping launch the rebirth of an annual Jensen Beach outdoor fine art event.

HOW TO APPLY

Application must be accompanied by payment of space fee and the non-refundable jury fee. Space fee is not refundable after the December 17, 2019. Applications will not be considered unless completed and accompanied by payment. A check deposit does not indicate acceptance into the show. Decisions by the show's Jury Committee are final.

No food vendors accepted. Local restaurants provide food and beverages. Downtown merchants and sponsors have the option of occupying a booth space in the show. These spaces must be clearly marked as a sponsor or business.

PHOTOS

Please submit photos digitally or by mail. One of the photos must be of the front view of your booth, the other photos must represent the quality of work to be displayed and sold.

MULTIPLE ENTRIES

Artists must choose <u>one category</u> on the application. Sharing booth space is not permitted. If items for sale do not reflect the category as stated on the application, you will be asked to remove such items.

Original works of art must be attributed solely to the displaying artist.

NO REFUNDS will be made after 12/17/19 date for any reason including inclement weather.

Guidelines 🦯

You are invited to participate in the 14th Annual Jensen Beach Fine Art & Craft Show. The show kicks-off the area's art show season and is considered one of the area's most authentic fine art and craft shows. The show is open to all artists who comply with the show guidelines.

All works must be original and must be attributed solely to the on site displaying artist. Artwork from molds, kits including other commercial methods or resale items are not eligible to participate in the show. Downtown businesses who choose to display in front of their stores and show sponsors are exempt.

For uniformity all tents must be white. Booth signage is required and must be professional and the name of the artist clearly displayed.

All works must be for sale. Booth spaces measure 10' x 10'. Work must be contained in the assigned space unless previous arrangements are made with show coordinators. Each artist must provide appropriate and secured display for outdoor exhibition. No vehicles are allowed near booth spaces or in show area during show hours. Set-up will begin Saturday morning, January 11, 2020 at 6:00 a.m.

No loud generators are allowed. No amplified music is permitted. Nails or screws placed in the streets or parking lots are strictly prohibited. Mandatory tent weights 100lb, 25lb on each corner.

Each artist is responsible for collecting 6.5% Florida Sales Tax and remit tax to the Florida Department of Revenue.

An application is a commitment to attend the show and remain an exhibitor for the entire event. Exhibitors leaving during show hours will forfeit invitations to participate in future shows. Exhibitors leaving the show after participating for only one-day will also forfeit invitations to participate in future shows unless excused by show officials.

Displays will be viewed by show officials. Show officials shall have sole discretion to require the removal of any work which violates guidelines or may be deemed inappropriate, including removal of an exhibitor for inappropriate behavior.

All exhibitors that are assigned a space on Jensen Beach Boulevard agree to have their exhibit space dismantled and removed by no later than 7:00 p.m. on Sunday in order to reopen the street to traffic. Failure to meet this requirement will result in forfeiture of Boulevard space at future shows.

Please indicate parking requirements on this application. Overnight RV parking is not permitted in public or private parking lots or grass areas. If you need information on local RV parks or lodging, please call (772) 334-3444.
