Booth Location: Booth spaces will be strategically assigned to avoid placing booths with similar items in close proximity to one another. Once you are assigned a space number you cannot move to another space without the permission from show director. Set-up will begin at 6am Saturday, January 10, 2015. You will be considered a no show and will forfeit space and fee if not setup by 9am.

Artists who were previously accepted by the jury committee will have first-priority on keeping assigned booth space. To keep booth space, advance payment for the 2015 show must be paid by January 31, 2014 and jury fee will be waived.

Security: Exhibitors bear the responsibility for all setup and security need for their exhibits. It is our assumption that each exhibitor is covered under their own insurance policy. All fire department safety lanes and rules will be strictly enforced. Security will be onsite from Saturday 6pm until Sunday 9am.

Jury fee: This is a juried show. Only 125 fine artists will be accepted. Jury fee applies to all new applicants. Jury fee is waived for previously accepted artist who have paid in

Show Guidelines

The Jensen Beach Chamber of Commerce invites you to participate in the 9th Jensen Beach Fine Art & Craft Show. Our show kicks-off the region's art show season and is considered one of the most authentic fine art & craft shows. Our show is open to all artists who comply with the show guidelines and only 125 fine artists will be accepted.

For uniformity, all tents must be white. Booth signage is required and must be professional, and the name of the artist clearly displayed. All works must be original works of fine art and craft. All work must be attributed solely to the displaying artist. Artwork from molds, kits or other commercial methods, or resale items are not eligible.

All works must be for sale. Booth spaces measure 10' x 10'. Work must be contained in the assigned space, unless previous arrangements are made with show coordinators. Each artist must provide appropriate and substantial display for outdoor exhibition – no vehicles allowed near booth spaces or in show area during show hours. Set-up will begin Saturday morning, January 10, 2015, 6am only.

No generators are allowed in the show. No amplified music is permitted. Nails or screws placed in the streets or parking lots is prohibited.

Each artist is responsible for collecting 6% Florida Sales Tax and to remit tax to the Florida Department of Revenue.

An application is a commitment to show and remain for the entire event. Exhibitors leaving before 5pm Sunday, January 11, 2015 will forfeit future invitations to participate in the show. Exhibitors must show both Saturday and Sunday from 10am until 5pm.

Displays will be viewed by show officials. The official shall have sole discretion to require the removal of any work which violates guidelines or is deemed inappropriate and including removal of an exhibitor for inappropriate behavior.

Designated parking for your vehicles, including RV's, is very limited and available on a first-come, first-serve basis. Please indicate parking requirements on this application. If you need RV park or lodging reservations, please call 772-334-3444. Overnight RV parking is not permitted in public/private parking lots.



Instructions

HOW TO APPLY – Application must be accompanied by payment in the amount of \$200 plus a \$25 non-refundable jury fee for all applicants. \$200 booth fee is not refundable upon acceptance. Applications will not be considered unless completely filled out and accompanied by payment. The bank deposit of booth fee payment does not indicate acceptance into the show. The decision of the Jury Committee is final. No food vendors accepted; local restaurants will provide food and beverages.

PHOTOS – Submit four photos by mail or digitally. One of the photos must be of the entire display, front view; the other three must be representative of the quality and the type of work to be exhibited.

MULTIPLE ENTRIES – Artists must choose only one category on the application. Sharing booth space is not permitted. If items for sale do not reflect the category as stated on the application, you will be asked to remove them.

NO REFUNDS will be made after December 19, 2014 for any reason, including inclement weather.
